Welcome to New England Law | Boston! We look forward to your arrival in August. This memorandum is to give you information about our required Introduction to the Study of Law Program during the week of August 16-20, 2010. All incoming students must attend this program.

The program for Day Division, Section D-02 students will begin on Tuesday, August 17 with registration at 8:15 a.m. and will conclude at 5:00 p.m. You will also need to take your first two Computer Assisted Legal Research (CALR) classes on Thursday, August 19. A schedule of events for your section is enclosed. Please note we will not be ready to register you until 8:15 a.m. and we also will have a light breakfast available for you during the registration time.

For your information, the Introduction to the Study of Law Program is scheduled before regular classes begin to give our incoming students an opportunity to meet one another and become familiar with the law school in a less hectic environment. You can buy your books, find your first class assignments, and figure out the logistics of the law school building and the surrounding area.

The substantive portions of the program are varied, and include lectures and panels on various aspects of the first year of law school and legal study. Our goal is to get you ready for the first few weeks of this new and exciting adventure! Some of your first year professors will be participating in the program and you will get a chance to meet them before the start of regular classes. Also, please note that a boxed lunch will be provided for your convenience. During the lunch time, you will be able to get to know your new classmates, or enjoy some quiet time by yourself. For your convenience, we have not scheduled any other activity during the time set aside for lunch.

As you may know, all of the law school's regular classes begin on Monday, August 23. Most of your professors will expect you to have prepared an assignment for the first day of class. # Required Computer-Assisted Legal Research (CALR) Training Schedule

The classes will take approximately 25 minutes apiece.

At the Introduction to the Library Class, which is part of Orientation, you will receive LexisNexis and WESTLAW passwords. Signup will be from the law library homepage ([www.nesl.edu/library/](http://www.nesl.edu/library/)) under Library News (in the right-hand column). **You must sign up for one Lexis class and one Westlaw class listed below.**

## **ALL INCOMING STUDENTS, PLEASE NOTE:**

### ***Legal Research & Writing I section assignments:***

The enclosed schedule includes all of your first-year courses with the exception of Legal Research & Writing I. All incoming students will receive their Legal Research & Writing I section assignments at Orientation. There will be an updated Fall course schedule in your Orientation packet; this updated schedule will have your LRW section assignment on it.

## **FULL-TIME DAY SECTIONS ONLY, PLEASE NOTE:**

### ***Full-time day division section assignments:***

On occasion, enrollments in the three full-time day sections (D-01, D-02 and D-03) may become unbalanced due to students deferring their enrollment to the next academic year. This may necessitate section reassignments for some students in the full-time day division. This is a very rare instance, but you should carefully check the Fall course schedule you receive at Orientation to see if your section assignment has changed.
