

LL.M. IN ADVANCED LEGAL STUDIES – FALL 2011

GUIDELINES PROGRAM ELIGIBILITY. This program is open *only* to graduates of law schools, or holders of law degrees from universities, located *outside the United States*.

DEADLINE. Applications for admission are due by **March 15**. The school will have difficulty processing late applications given the time needed by admitted students for U.S. immigration authorizations.

CHECKLIST The following must be included with your application:

- Completed and Signed Application Form
- Personal Statement
- Non-refundable Application Fee of \$100 USD (payable to: **New England School of Law**).
- Official Transcript from Law School or University Granting Law Degree (translated into English, if not in English). Applicants whose degree is from outside Canada must have their transcript certified and analyzed as set forth below.
- Statement of Financial Proof (see attached page).

Arrange for the following when you send your application:

- Certification and Analysis of Law School or University Transcript, sent directly to New England Law by one of the services listed below.
- Official Test of English as a Foreign Language (TOEFL) Score, sent directly to New England Law by TOEFL (see below), unless English is applicant's first language or was language of instruction at university granting law degree or law school.

SERVICES (Applicants are responsible for all fees associated with these services.)

TRANSCRIPT ANALYSIS. If your law degree is from an institution outside Canada, it must be certified as the equivalent of a U.S. law degree. Academic analysis may be obtained from these agencies:
