

What is e2Campus?

E2Campus is a text-messaging system that allows New England Law | Boston to communicate with members of the campus community quickly in the event of an emergency. Once a person completes the sign-up process, notifications may be sent through text messages, voicemail, and e-mail.

Is e2Campus just for cell phones?

No, the e2Campus text-messaging system can send messages to any device that can receive text messages through cellular service, such as cell phones, text pagers, BlackBerrys, and some wireless PDAs. E2Campus messages may also be sent to e-mail addresses registered through the e2Campus system and to voice mail.

When will I get an e2Campus message?

The law school has created a well-defined set of situations that would prompt an e2Campus message. Here are some examples of when the text messaging service would be used:

- Ongoing safety threats in which an armed or dangerous person is at large on or near campus.
- Major facility emergencies or evacuations. This may include a large-scale gas leak, fire, or hazardous material spill, occurring either on campus or near campus.
- Severe weather requiring closing due to anticipated weather issues.

What if I don't have a cell phone or my cell phone doesn't have text messaging?

E2Campus is just one of the communication channels used in the event of an emergency. It is not replacing any of our other previous methods of communication; it only helps to expand our methods of reaching the campus community. In addition, you can sign up to have alerts sent to your e-mail address and voice mail.

How do I sign up for e2Campus?

It's easy! Go to <http://www.e2campus.com/my/nesl/> and click on 'I need to create an Account' to begin the process.

How long will it take to receive an e2Campus message?

E2Campus text messages are sent with urgency, and our goal is to ensure that they are received in a timely manner. The e2Campus text-messaging system can distribute about 500 text messages per second. However, cell phone providers may not be able to accept messages at the same pace.

Because e-mail messages distributed through the e2Campus system are likely to be received more promptly, we advise you to register for both methods of communication through the sign-up process.

How can I get more information once I receive an e2Campus message?

Due to the limitations of text messaging, e2Campus messages will be very brief and contain vital and immediate information.

Will I get advertising messages from e2Campus?

No. e2Campus will not be used to deliver any kind of advertising content, and mobile numbers will not be shared with any third parties.

Can my parents or guardian subscribe to e2Campus?

The law school has arranged for a limited number of subscriptions only for New England Law students, faculty, and staff members.

Does signing up for e2Campus cost me anything?

There is no cost to sign up for e2Campus. The only charges you incur would be the normal fees charged by your mobile service provider for receiving text messages.

Why is e2Campus necessary?

The number of mobile telephones and the use of text messaging have made this a key method to reach people immediately.
